# Introduction

Universal health coverage is the vision that everyone, everywhere should have access to quality and affordable health services.

Stronger health systems are the backbone of progress towards UHC and all the health SDG targets.

UHC2030 is the global movement to build stronger health systems for UHC. It provides a platform to convene and build connections through joint high-level events or gathering of experts and contributes advocacy, tools, guidance, knowledge and learning. This supports all relevant stakeholders to take more effective and coherent action in support of countries' efforts to achieve UHC, based on a shared vision for health systems that protect everyone and a shared commitment to leave no one behind.

One of our priorities is to convene the Health Systems Related Initiatives: a diverse group of international partnerships, alliances and networks focused on strengthening different aspects of health systems.

This document provides a short profile for each Related Initiative, with details about their activities and opportunities to work together.

All of the initiatives listed in this document are part of the UHC2030 family and provide crucial support to the global movement for UHC. They share a commitment to promote the principles of the [UHC2030 Global Compact for Progress towards UHC](#) and common approaches to strengthening health systems embedded in [Healthy systems for universal health coverage - a joint vision for healthy lives](#).

## Alliance for health policy and systems research

The Alliance for Health Policy and Systems Research (the Alliance) works to improve the health of those in low- and middle-income countries by supporting the generation and use of evidence that strengthens health systems.

It is an international partnership hosted by the World Health Organization, working together with organizations around the world. It believes in the power of research to inform health policy decisions, drive health care reforms, scale-up proven health interventions, and ultimately save lives.

It engages diverse actors in health policy and systems research targeting support to ensure better inclusion of and participation by women, those in low- and middle-income countries and other historically underrepresented groups.

### Objectives

- Provide a unique forum for the health policy and systems research community.
- Support institutional capacity for the conduct and uptake of health policy and systems research.
- Stimulate the generation of knowledge and innovations to nurture learning and resilience in health systems.
- Increase demand for and use of knowledge for strengthening health systems.

### Priorities and activities

Over the last two decades, the Alliance has supported nearly 400 projects in 73 countries. For example:

- In Lebanon it supported a rapid review centre to bring evidence into health care debates.
- In Haiti, it helped the Ministry of Health improve programmes using an embedded research approach.
- In Nigeria, participatory action research engaged communities in dialogues about barriers to immunisation services and developing action plans.

## Global Action Plan for Healthy Lives and Well-being for All – PHC Accelerator

Primary Health Care (PHC) is one of seven key accelerator areas identified by SDG3 GAP partners to focus and align efforts to accelerate country progress towards SDG3. By weaving together multisectoral policy and action, empowered people and communities, and people-centred integrated health services at population and individual levels, the PHC vision addresses the broader determinants of health and access, use and affordability of quality health services – all of which are essential for the achievement of UHC, SDG3 and other health-related SDGs.

The PCH Accelerator (PHC-A) supports countries in developing and delivering a comprehensive package of essential health services and contributing to UHC through PHC, using the PHC operational framework, measurement framework and indicators as key tools to accelerate progress. Country collaboration under the PHC-A is based on the principles of country ownership, using a bottom-up approach. It is built on tailored support plans responding to national contexts and priorities. Implementation of the work of the PHC-A has followed a consultative process and engagement with regions to identify and prioritize initial countries to support.

### Objectives

- Engage, accelerate, align and account with WHO and UNICEF as the lead agencies supporting collaboration for national efforts on PHC with other GAP signatory agencies.
- Provide a platform for government-led country dialogues on PHC and align partner support to national PHC priorities and strategies.
- Serve as a forum for global PHC strategy discussions among partners.
- Support the development and dissemination of global goods for PHC.

- Support countries in their PHC measurement efforts at national and sub-national levels.
- Support better alignment of measurement efforts at global, regional and country levels.

## Health Data Collaborative

Established in March 2016 following the high-level summit on [Measurement and Accountability for Results in Health](#), the Health Data Collaborative (HDC) convenes stakeholders from across the health data and digital ecosystem to strengthen country Health Information Systems (HIS), align partner resources with country priorities, and adapt global tools to local contexts.

### Objectives

- Strengthen country capacities to plan, implement, monitor and review progress and standardized processes for data collection, availability, analysis and use.
- Improve efficiency and alignment of technical and financial investments in health data systems.
- Increase the impact of global public goods and tools on country health data systems through increased sharing, learning and country engagement.

JLN member countries share experiences, work together and co-develop global knowledge products and tools that help bridge the gap between theory and practice. All activities are prioritized, shaped, led and co-facilitated by countries.

### Objectives

- Establish a vibrant community of member countries deeply engaged in practitioner-to-practitioner learning to jointly generate knowledge, solve problems and adapt tools.
- Provide countries with a self-governed collaborative learning environment to harness collective expertise and experiences.
- Strive to maintain country-led priority setting, flexibility, and a strong community where members feel a sense of belonging, trust and friendship.

## Universal Health Coverage Partnership

The Universal Health Coverage Partnership (UHC-P) promotes UHC by fostering policy dialogue on strategic planning and health systems governance, developing health financing strategies and supporting their implementation, and enabling effective development cooperation in countries.

Since it started in 2011, it has evolved into a significant and influential global partnership working in 115 countries in all 6 WHO regions, with the support of seven significant donors.

### Objectives

- Build country capacity and reinforce the leadership of health ministries to build resilient, effective and sustainable health systems in order to make progress towards UHC.
- Bridge the gap between global commitments and country implementation and serve as a country-level resource for UHC2030.

### Priorities and activities

- Engage in policy dialogue among a range of health stakeholders.
- Provide flexible funding for country-selected priority areas.
- Deploy technical assistance through senior health systems advisors in WHO country offices, in direct support of health ministries.

## Working for Health

Working for Health is a multisectoral partnership, coordination, and financing initiative between the World Health Organization (WHO), International Labour Organization (ILO) and the Organisation for Economic Co-operation and Development (OECD). It was established in 2018 to accelerate policy, action, and investments in health workforce education, skills, jobs, safeguarding and protection, in response to the projected global shortage of 10 million health care workers by 2030.

Working for Health and its Multi-partner Trust Fund mechanism are key to advancing universal health coverage (UHC) and Sustainable Development Goals 3, 4, 5 and 8 (health, education, gender equality, decent work, and economic growth) through the expansion and transformation of the health and care workforce, to improve health, economic, and social outcomes.

### Objectives

- Optimize the existing health and care workforce, creating and distributing the skills and jobs needed to deliver UHC.
- Build the diversity, availability and capacity of the health and care workforce, addressing critical shortages by 2030.
- Strengthen the protection and performance of the health and care workforce to deliver health for all and respond to emergencies.

Working for Health supports over 40 countries to leverage investments in workforce policy, planning and financing, education and employment, protection, and performance. Its catalytic technical and funding support to countries and regions has facilitated multi-sectoral policy dialogue, evidence-based decision making, action and investment in the health and care workforce, and increased access and availability of health and care workers where they are most needed.
