High-level Political Forum

- HLPF is the main UN platform for the follow up and review of the 2030 Agenda
- It was established by the Rio+20 Outcome document to inter alia provide leadership, guidance and recommendations on the implementation of the SDGs, facilitate exchange of experiences and best practices, and promote system-wide coherence and coordination
- HLPF meets annually under the auspices of the UN Economic and Social Council and every fourth year under the UN General Assembly.
